



What We Do

Policy and Programs

- Carries out the vital work of educating policymakers and the field about key strategies and policies for ending and preventing homelessness.
- Keeps federal policymakers and legislators informed of the needs of people experiencing homelessness and the programs serving them.

Capacity Building

Why an Emergency Shelter Training?

- Implement a system-wide approach to ending homelessness
- Align emergency shelter's goals with the CoC goals to end homelessness
- Provide low-barrier, safe, and housing-focused shelter that people will use
- Increase the number of people that exit from shelter to permanent housing (and decrease the number exiting back into homelessness)
- Shorten the length of time people experience homelessness

Effective, Equitable and Efficient Homeless Response System: **GOAL**

House people as quickly as possible and divert people from imminent homelessness whenever possible



Effective, Equitable and Efficient Homeless Response System: **APPROACH**

Use a systemic approach

to align interventions and resources across programs in a coordinated way around this common goal



Effective, Equitable and Efficient Homeless Response System: **ENDGAME**

Homelessness is rare, brief, and one-time

- People in a housing crisis have access to immediate help, including a safe place to go
- People are not unsheltered
- People do not spend long periods of time homeless
- People exit homelessness quickly and do not quickly cycle back into homelessness
- Black people are not overrepresented in those experiencing homelessness



Effective, Equitable and Efficient Homeless Response System: **PERFORMANCE**

Establish systemic performance measures

- 1. Reduce in-flow into homelessness
- 2. Increase exits to permanent housing
- 3. Decrease average length of homelessness
- 4. Decrease returns to homelessness



An Effective Homeless Response System: **PRACTICE**

Practice Standards Across all Programs

- Housing First approach across all interventions within the system
- **Diversion** from imminent homeless system when safe and appropriate
- Rapid identification and engagement of people experiencing unsheltered homelessness to connect them to crisis services and housing assistance



An Effective Homeless Response System: **PRACTICE**

Practice Standards Across all Programs


- Quick, accessible, low-barrier pathways to shelter and other crisis services with short stays in shelter
- Rapid connection to permanent housing for all sheltered and unsheltered people, whether or not they are matched to a housing resource through coordinated entry



An Effective Homeless Response System: Increase System Flow

System Flow:

An efficient and coordinated **process** that moves people from homelessness to housing as quickly as possible



The "process" means that all interventions need to work as one system to create flow.





Debrief

Purpose

- Regrouping point for individuals
- Connect with support
- Temporary safe space
- Should be available for everyone (including severe mental illness)



Who is shelter for or doesn't work for

- Should be for everyone
- It's for everyone certain shelters are tailored for certain household types
- What does community care coordinator look like after someone exits shelter/housed from shelter – follow-up

Can't work for...

- People who cannot care for themselves
- People with pets
- Clients with mental health issues
- Those that get cut off from shelter services when they leave but still need the shelter services
- Someone not ready to be housed



Purpose of shelters/crisis housing?

- To provide temporary shelter
 - Hostel-like environment (check-in and check out every day)
 - Meets basic needs
 - Shower/bathroom
 - Laundry
 - Mail
 - Self-directed resource/information and referral
 - Light services

- To end homelessness
 - Resolve housing crises permanently
 - Facilitate self-resolution
 - Re-house people quickly
 - Reduce unsheltered homelessness
 - Create better system flow
 - Connect people to coordinated entry
 - Connect people to housing search and other resources to help stabilize them once housed





Role of Emergency Shelter

What role does it play in achieving the goal?

- Ensures individuals and households experiencing homelessness have a safe, decent place to stay that that is immediately accessible while focusing on quickly exiting people to housing
- Provides housing support within shelter or connections to rapid re-housing and other housing resources for rapid exits to housing.

Why Are Shelters So Important?

- People in a housing crisis will always need a safe and decent place to go that is immediately available
- Shelters will most likely be the only place people receive help to resolve their housing crisis and get connected to permanent housing
- Shelter eligibility, policies, and stays impacts performance outcomes and system flow

- Analysis of Why Some People Refuse Shelter
- Engage and Listen to People with Lived Experience

What Do We Know About Shelter Stays?

Significant portion of people self-resolve or seek help from another system

Most people can exit homelessness with a light touch of services and assistance, and exit homelessness for good

People who have highest needs often lose shelter beds due to noncompliance issues

Minority of people need more intensive services and long-term housing supports




Reality of the numbers

2023

- AHAR (annual):
 - 2374 people experiencing homeless
 - 3,175 people experiencing for the first time


2024

- CES numbers:
 - 795 on average new and reassessed HH monthly
 - 98 on average RRH (49) and PSH (49) HH Monthly







Local Data Austin/Travis County 2023 PIT





Do We Have the Right Mix?






2023 HIC Shelter Beds 1200 1020 1000 800 607 600 403 400 200 ■ Total ES Beds Family Individual




Housing Inventory Beds Available vs Beds Used 2023




2023 PIT

Emergency Shelters in the CRISIS RESPONSE SYSTEM

- Housing crisis resolution
- Shared Housing
- Family and Friends
- Rapid Re-housing
- Permanent
 Supportive Housing
- Market rate housing
- Voucher



The Role of Shelter in the Crisis Response System...Ideally


- Integrated with coordinated intake system (accepts referrals, provides real-time data)
- Diverts people who can safely maintain their current housing
- Prioritizes shelter for those who need it most
- Provides immediate and low-barrier access through coordinated entry to shelter and crisis services without barriers to entry, as stable housing and supports are being secured
- Practice must align with what unsheltered people need
- Quickly connects people who experience homelessness to housing assistance and/or services tailored to the unique strengths and needs of households





People have to be able to get *in*...

...and be able to get *out* (to housing).

Challenges

Getting in shelter

- Non-compliant coming back
- Full
- Not accept folks under 18
- Pets
- Intake process
- Outdated assessment
- People don't want the rules like having their freedom
- People come back that have been housed and process didn't work

Getting out of shelter to stable housing options

- People "not fond" of employment
- People see shelter as the last stop, not wanting to leave shelter
- People not accepting what's available for them, choose to not use housing options provided to them
- Addictions makes it hard to focus on the housing goal
- People waiting for disability determination and not eligible for resources...sit and wait


Key Elements of Emergency Shelters in an Effective Crisis Response System
